

This document outlines the Official Terms and Conditions (“Terms and Conditions”) for the Global Village – Dubai Holding Raffle Draw (“Draw”) for Global Village Season 24. Global Village reserves the right to modify, alter or otherwise update these Terms, Conditions from time to time, as it deems fit and such modifications, alterations or updates shall automatically be binding on all the Draw participants (“Users”).

1. ELIGIBILITY

1.1 The Draw shall be open to all Users who:

1.1.1 Have purchased a Global Village entry ticket, VIP pack, or a minimum of AED100 Wonder Pass

1.2 The following are NOT eligible to participate in the Draw:

1.2.1 Employees, officers, directors, agents and representatives (or families) of Arab Media Group (AMG) and their subsidiaries.

1.2.2 Employees, officers, directors, agents and representatives of any advertising, promotional, public relations, legal or other professional agency or firm providing services/advice directly to Global Village in relation to the Draw and related matters;

1.2.3 Global Village ID card holders and/or employees of Global Village investors or partners.

1.3 Global Village reserves the right to modify at any time the eligibility of Users.

2. COMPETITION PERIOD

2.1. The Draw shall commence on January 4th 2020 and will end on April 3rd 2020 (“Draw Term”).

2.2. Global Village may, at its own discretion change the dates and times of the Draw and notify the Users accordingly.

3. APPLICATION PROCESS

The Users must fill out the application form in English or Arabic and enter their details such as their full name, email address, phone number and other details as requested on the Draw’s dedicated online portal URL: <https://win.globalvillage.ae/> (“Portal”)

3.1 Each entry ticket purchased for AED 15 constitutes one entry for the Draw. Every AED 100 loaded onto a Wonder Pass card gives 1 entry for the Draw. Each VIP Pack purchased for Global Village Season 24 will also give one entry to the Draw.

3.2. The Users' submission of their required information on the Portal shall constitute the Users' consent and agreement to (i) these Terms and Conditions; (ii) their participation in the Draw in accordance with these Terms and Conditions; (iii) grant Global Village the right to use and publish the User's name and photo in media for the purpose of the Draw.

4. THE INFORMATION SUBMITTED BY YOU

Global Village respects the privacy of the Users and hereby undertakes that any and all information provided by the Users on the Portal will only be used in accordance the applicable data protection rules and regulations and Global Village's Data Privacy and Cookies Policy.

5. GRAND PRIZE WINNER

5.1. The Grand Prize Winner shall be selected by a random computer-generated raffle draw on April 3rd 2020 from all the submitted information;

5.2. Global Village shall announce the Grand Prize Winner on April 3rd 2020

5.3. Pursuant to Clause 5.2 above, the Grand Prize Winner acknowledges and consents that:

5.3.1. The prize for Global Village's raffle draw is a one bedroom apartment in Dubai Wharf at Jaddaf Waterfront, Dubai, UAE.

5.3.2 The winner is responsible for providing all identification cards and documents requested by Global Village to be able to claim their prize.

5.3.3 Upon receiving the required documents from the winner, Dubai Holding, being the current owners of the apartment, will initiate the registration process to transfer the ownership to the winner with the respective government authorities and departments. Winner is required to attend any meeting needed for completing the procedures.

5.4. The Grand Prize Winner acknowledges and agrees that Global Village has the right to publish and announce their full name through any and all media formats including but not limited to the Global Village Official Website, and Social Media accounts;

5.5 For the avoidance of doubt, Global Village is under no obligation to announce the name of the Grand Prize Winner.

5.6. The Grand Prize Winner shall not be permitted to replace their Prize with another prize or item; (b) transfer or assign their Prize to another person, (c) redeem their Prize for cash; (d) refund their Prize; (e) combine their Prize with any other offer or promotion.

5.7. Global Village reserves the right, exercisable at any time in their sole discretion, to substitute the Prize (or portion thereof), provided that the substitute prizes are items of

comparable or greater value.

The Prizes are awarded “as is” with no warranty or guarantee, either expressed or implied by the released parties.

5.9. After receiving a winning notification, the Grand Prize Winner must confirm their contact details via email within seven (7) days of being contacted by Global Village. In the event the Grand Prize Winner fails to contact Global Village within the seven (7) days period, he/she shall be considered to have forfeited the Prize and Global Village shall select a winner from the remaining eligible entries or dispose of the Prizes in any way it deems fit.

5.10. The Grand Prize Winner acknowledges and agrees that he/she may be expected to take part in reasonable publicity activities and promotional events promoting Global Village or Dubai Holding.

5.11. To the fullest extent permitted by law, Global Village shall not be liable for any direct, indirect or consequential loss or damages whatsoever which is suffered in relation to the delivery of the Prize to the Grand Prize Winner and/or this Draw.

6. GENERAL

6.1. By submitting the information, the Users agree that:

6.1.1. Global Village and any employees, officers and affiliates may use and disclose (to the fullest extent permitted by applicable law User’s name, city and state of residence, photograph, any oral or written statements, footage, and/or likeness for advertising, trade and/or any other purposes in any media and/or social media and/or on TV now or hereafter known throughout the world in perpetuity, without further compensation, permission or notification;

6.1.2. Global Village is hereby granted an authorization and consent to conduct any and all verifications required concerning the User’s identity;

6.1.3. The Users shall be disqualified from the Draw in the event of the existence of any indication of falsified, fraudulent, false, untruthful, incorrect or inexact identity or address of any User.

6.1.4. Global Village (including affiliates, officers and employees) shall, except where caused by gross negligence, have no liability and shall be held harmless by the Users for any claims, demands, obligations, liability, suits, actions, proceedings, judgments, fines, losses, damages, penalties, charges, costs and expenses (including, without limitation, attorney’s fees) in relation to the Draw or any other person or entity, including, without limitation, personal injury or death to User or any other person or damage to personal or real property, arising from or related to this Draw, or due in whole or in part, directly or indirectly, to (i) the acceptance, possession or use of the Prizes, (ii) any physical activity, travel or travel-related activity in relation to the Draw or participation in this Draw; and

6.1.5. Global Village reserves the right, in its sole discretion, to modify, suspend, and/or terminate this Draw and the Terms and Conditions (or portion thereof) without any notice to the Users, at any time and for any reason whatsoever especially if virus, bugs, non-authorized human intervention or other causes corrupt or impair the administration, security, fairness or proper play of the Draw or for any other reason.

7. DELIBERATE DAMAGE

7.1. Any attempt to deliberately damage or undermine the legitimate operation of this Draw may constitute (where applicable) a violation of criminal and civil laws and should such an attempt be made, Global Village reserves the right to seek damages (including attorneys' fees) and/or other remedies from any such person(s) responsible for the attempt to the fullest extent permitted by law and shall be reported to the relevant courts in the emirate of Dubai or in the United Arab Emirates according to the applicable laws of Dubai or the United Arab Emirates.

7.2. Failure by Global Village to enforce any of its rights under these Terms and Conditions, at any stage, does not constitute a waiver of those rights.

7.3. These Terms and Conditions are governed by the laws of the emirate of Dubai and the laws of the United Arab Emirates, where applicable. The Courts of Dubai shall have exclusive jurisdiction to hear and decide any suit, action or proceedings, and/or to settle any disputes, which may arise out of or in connection with these Terms and Conditions.
